

NOTICE OF REGULAR TAX SALE

Notice is hereby given that the annual Tax Sale will be held by the Hardin County Treasurer on Monday, June 15, 2026, at the Hardin County Treasurer's Office on the first floor of the Hardin County Courthouse, 1215 Edgington Ave, Eldora, Iowa, beginning at 9:00 a.m. All bidders must register online by Wednesday June 10, 2026, and all bids must be placed online. No mailed or emailed registrations will be accepted. Registered bidders can access the auction site by going to www.govease.com. Following the Public Bidder Tax Sale at 9:00 a.m. the Hardin County Treasurer will offer for sale all taxes that remain unpaid at the time of sale (including real estate, mobile home taxes, special assessments, and drainage assessments). The individual bidder, under the provisions of this sale, Iowa Code 446, must bid for the total amount of general and special tax. After the sale, if the parcel is not redeemed within the period provided in Chapter 447(Tax Redemption), the right to redeem expires and a deed may be issued. A treasurer's deed may be issued at the expiration date of two years from the date of sale.

Any taxpayer affected may avoid tax sale proceedings by making payment to the Hardin County treasurer by 4:30 p.m., Friday, June 12, 2026. Property taxes may also be paid on-line at www.iowatreasurers.org.
