

WASHINGTON COUNTY TREASURER'S PUBLIC NOTICE
Annual Tax Sale

Notice is hereby given that the Washington County Annual Tax Sale will be held on Monday, June 15, 2026, at the Washington County Courthouse beginning at **9:00 am**. I will offer for sale all parcels below for which taxes are delinquent for any period and sell those properties indicated with an '**S**' which were previously advertised for one year or more and not sold, as required by Chapter 446, Code of Iowa.

All bids must be placed online at www.iowataxauction.com. Those wishing to bid at the annual tax sale must register online at www.iowataxauction.com by June 11, 2026. Registrations will not be accepted after that date.

The sale shall be made for the total amount of taxes, special assessments, interest, and service fees due. Any commencement of court action, authorized by law for collection of all other taxes, shall commence ten days after publication of this notice. This notice and delinquent parcel listing will appear once on June 4, 2026, and will show the name of the person to whom taxed, a description of the parcel, the district, the parcel number, and the amount of taxes, special assessments, interests, and service fees, all incorporated as a single sum.

Properties for which a notice of bankruptcy is on file are indicated with a '**B**' and will be withheld from the sale. Any listing contained herein for which a notice of bankruptcy or suspension is received after publication will also be withheld from sale.

All parcels remaining unsold on the sale date will be offered at adjourned tax sale which may be held any business day following the annual tax sale as long as there are bidders present and parcels remain available for sale.

After the sale, if the parcel sold is not redeemed within the period provided for in Chapter 447, the right to redeem will expire and a deed may be issued. Any publication errors or irregularities do not affect the legality of the tax sale.

Guaranteed funds are required for property tax payments pursuant to Iowa Code section 331.553.3.
